MEMORANDUM OF UNDERSTANDING BETWEEN NOWGONG COLLEGE AND HEST FEDERATION

This Agreement (MoU) is executed and made effective this Thursday of 9th July ,2020 by and between Industrial Incubation of Entrepreneurship & Skill Training Federation (IIEST Federation), a not-for-profit company, registered under section 8 companies act, the laws of India, having its registered office atbuilding no. 55 Panchkuian Marg, Connaught Place, New Delhi-110001 (herein after referred to as IIEST Federation which term shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns) of the first part;

AND

Nowgong College, A. T. Road, Nagaon, Assam, PIN:782001(hereinafter referred to as "Nowgong College" and which expression shall unless it be repugnant to the context or meaning thereof deemed to mean and include its executors successors and assigns) of the second party.

IIEST Federation and the "NowgongCollege" are hereinafter referred to individually as "Party" and collectively as "Parties".

WHEREASIIEST Federation is anot-for-profit companyimparting awareness, training, & handholding to young members in sustainable employment and sustainable self-employment through under government of India aegis.

WHEREASNowgong College which offers skill-oriented Certificate Courses to their students to achieve vocational qualifications besides their Undergraduate degree courses. In this regard Nowgong College desires to offer the B. Voc. Three year Degree/Advance Diploma/Diploma inHealth Care Technology/Pharmaceutical Chemistryfor a duration of three (03) years under UGC scheme of 'National Skills Qualifications Framework' (NSQF) to their students for 180 credits after 10+2 and IIEST Federation agrees to be the knowledge partner inB. Voc Course of 3 yearsinHealth Care Technology/Pharmaceutical Chemistryto the students of Nowgong College. Both the parties are bound by the guidelines of NSQF guidelines of UGC.

NOW therefore, in consideration of the mutual agreement hereinafter set forth, and other good and valuable considerations, the Parties hereby agree as follows:

1. HEST FEDERATION OBLIGATIONS

- 1.1 The IIEST Federation will be the industry partner of the program.
- 1.2The institution may engage the expert/trainer from the industry partners as per UGC guidelines of contractual appointments.
- 1.3The visibility may be given to the industrial partner through the program.
- 1.4The Workshops and field visits may be organized in collaboration with the industry partner.

2. Nowgong College OBLIGATIONS

- 2.1 To conduct the training at the college location to fulfill the prescribed credits for certificate course.
- 2.2 The institution shall prepare draft curriculum as per NSQF guidelines and as per the provisions enumerated in MHRD Skill Assessment Matrix for Vocational Advancement of Youth. The draft curriculum will be developed in consultation with the industry partner. The Skill component and Education component shall be as per UGC guidelines. The curriculum shall be considered and approved by the appropriate academic mechanism of the University.
- 2.3To provide training aid, viz. terminals / projector and other basic requirement for the training such as smart board, podium, microphone etc. and the equipped lab for computerized systems.
- 2.4. To safeguard intellectual property of IIEST Federation and its faculty used for the course work
- 2.5 To provide certification on completion of credits by the students as authorized by the competent authority.

3. TERM

The AGREEMENTshall come into force, shall be valid for one (01) year (two term) i.e. two terms of 6 months each and thereafter may get renewed for subsequent terms of one year each (six months) upon mutual consent after approval from UGC.

4. PAYMENT TERMS

- 4.1. Nowgong Collegeagrees to pay to the trainer/expert as per UGC norms.
- 4.2. The course content/ curriculum will be developed in consultation with the industry partner, and the consultation fee for this purpose may be given to compensate the time used for it.
- 4.3 The Workshops and fieldworks will be as per norms of the institution and the industrial partner does not have to bear any expenditure on this account.

5. RELATIONSHIP

The relationship between the Parties is that of principal to principal and in no case would be construed to have affected the Employee/Employer relationship. Nothing in this Agreement shall be constructed as creating a partnership or joint venture of any kind between the Parties or as constituting either Party as the agent of the other Party for any purpose whatsoever and neither Party shall have the authority or power to bind the other Party or to contract in the name of or create a liability against the other Party in any way or for any purpose.

6. DISPUTE RESOLUTION

- 13.1. The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this AGREEMENT or the interpretation thereof.
- 13.2. The Parties agree that the Courts in Delhi shall alone and exclusively have jurisdiction over all disputes arising out of this AGREEMENT.

7. ENTIRE AGREEMENT

This AGREEMENT, including the entire agreement and understanding between the Parties. This AGREEMENT supersedes all oral and written representations and understanding between the Parties including, but not limited to any earlier assignment relating to the subject matter thereof any other arrangement between the Parties in relation to the subject matter thereof.
