B) B.A. in Arts under CBCS of Dibrugarh University

Choice Based Credit System (CBCS) has been introduced in B.A. Programme from academic session 2019-2020.

Meaning and Goal of CBCS

Choice Based Credit System (CBCS) is a flexible system of learning. It has two components: First is Choice and the Second is Credit 'Choice' provides more flexibility to students in choosing the subjects for study. CBCS allows students to choose interdisciplinary, intra-disciplinary courses, skill oriented papers (even from other disciplines according to their learning needs and interests). 'Credit' defines the quantum of contents/syllabus prescribed for a course and determines the number of hours of instruction required per week. One credit is equivalent to one hour of teaching (lecture or tutorial) or two hours of practical work/field work per week.

1 Lecture(L) per week = 1 Hour duration

per week = 1 Credit

1Tutorial(T) per week = 1 Hours duration

per week = 1 Credit

1 Practical(P) per week = 2 Hours duration

per week = 1 Credit

1 Credit Course = 15-16 hours of lectures per semester.

A study course can have only **L** component or only **T** or **P** component or combination of any two or all the three components.

The ultimate goal of CBCS is to bring reforms in higher education so that students develop thinking as well as analytical ability he/she gets equipped with necessary skill ultimately making him/her suitable for employment and to integrate values of culture with education.

Some important terminologies used under the CBCS:

Academic Year: Two consecutive semesters.

Programme : Programme means the entire course

of study traditionally referred to as

course-B.A.

Course : Course usually referred to as 'paper'

is a component of a programme. A course may be designed to comprise lectures/ tutorials/laboratory work/ field work/ outreach activities/ project work/ vocational training/viva/ seminars/ term papers/assignments/presentation.

Credit Point: Credit Point = Credit earned by a

student x Grade Point earned by

him/her.

Grade Point: Grade is the transformation of scaled

marks secured by a student in a course (both in mid semester and end semester examination) on a 10-point

scale.

Semester Grade Point Average (SGPA):

SGPA = Total credit points earned in a semester

÷ Total credits allotted for that semester

Cumulative Grade Point Average (CGPA):

CGPA is a measure of overall cumulative performance of a student over all semesters. The CGPA is the ratio of total credit points secured by a student in various courses in all semesters and the sum of the total credits of all courses in all the semesters.

CGPA= Total number of credit points earned in all the semester ÷120 (the total number of credits in all the semester)

Conversion of Formula for the Conversion of CGPA in to Percentage:

CGPA Earned - $0.75 \times 10 = Percentage of Marks Scored$

Continuous and Comprehensive Assessment(CCA):

Continuous and Comprehensive assessment is an integral part of CBCS. A continuous assessment system in semester system (also known as internal assessment/comprehensive assessment) is spread through the duration of course and is done by the teacher teaching the course. The assessment is done through various means including:

- O Written tests
- O MCQ based quizzes
- O Presentations
- O Projects
- O Field visits
- O Seminars
- O Group discussions/activities etc

Semester System:

The entire B.A. course is divided into six semesters. Each semester will consist of 15-16 weeks of academic work equivalent to 90 actual teaching days. Each week has 30 hours of instruction.

Semester Duration:

- a. Odd Semester: June-November (including endsemester examinations and semester breaks)
- b. Even Semester: December-May (including endsemester examinations and semester breaks)

Course Structure: Courses in a programme may be of three kinds:

a) Core Courses: (Honours Courses): Core Course is the course which is to be compulsorily studied by a student as a core requirement to complete the requirement of a programme in a said discipline of study. It may be of two types- Hard Core and Soft Core. Hard Core have to be done without exception. There will be no choice available. Soft Core have to choose a certain number of core course out of the given number. Some degree of choice available in soft core.

- a) Elective Course: Elective course is a course which can be chosen from a pool of papers. Elective courses are of two types-Discipline Specific Elective which is intra disciplinary and Generic Elective which is inter disciplinary.
- (i) Discipline Specific Elective (DSE) Course: An elective course offered by the main discipline/subject of study is referred to as Discipline Specific Elective.
- (ii)Generic Elective (GE) Course: An elective course chosen generally from an unrelated discipline, with an intention to seek exposure is called a Generic Elective. A core course offered in a discipline may be treated as an elective by other discipline and vice versa. A student in a particular department can opt for General Elective Courses offered by other department only. For example- a student admitted under BA Hons. In History programme can not opt for General Elective Courses offered by the History Department.

b) Ability Enhancement Courses (AEC)/ Foundation Courses:

The AEC may be of two kinds: Ability Enhancement Compulsory Courses (AECC). Ability Enhancement Elective Courses (AEEC)/Skill Enhancement Courses (SEC)

(I)Ability Enhancement Compulsory Courses (AECC):

AECC courses are the courses based upon the content that leads to Knowledge enhancement. The universities participating in

CBCS system may have common curriculum for these papers. There may be one paper each in the 1st two semesters viz. (i) English/MIL Communication, (ii) Environmental Science. These are mandatory for all disciplines.

(ii) Ability Enhancement Elective Courses /AEEC)/Skill Enhancement Courses (SEC):

These courses may be chosen from a pool of courses. AEEC/SEC courses are value-based and/or skill-based and are aimed at providing hands-on-training, competencies, skills, etc.

Eligibility for Admission:

A student who has passed the Higher Secondary School Examination (HSS 10+2) under Assam Higher Secondary Education Council (AHSEC) or an equivalent examination shall be eligible for admission.

Cut off Marks for Admission in to B.A. 1st Semester

- (a) For Honours Course: 45% (In the subject sought to take honours)
- (b) For Non-Honours Course: 35% (in aggregate)

Attendance:

- 80% of attendance during the total number of class days is mandatory.
- ☐ A student who has less than 80% attendance in average shall not be permitted to sit for the End-Semester Examination.
- ☐ A student who has obtained a minimum of 70% of attendance but failed to obtain the prescribed 80% attendance for valid reasons, on recommendation of the principal and on payment of a Prescribed fee(s) the university will grant exemption to the student.

Examination and Evaluation:

- a. Examination and evaluation shall be done on a continuous and comprehensive basis, at least three times during each semester.
- b. There shall be 20% marks for internal assessment and 80% marks for End-semester examination in each course during every semester examination in each course during every semester.
- c. A candidate shall be declared as passed a Course, provided he/ she secures -
 - (i) at least 40% of marks in each Course in the End Semester Examinations.
 - (ii) at least 'P 'Grade in the 10 point scale combining both the In-semester and End-Semester examination performance.
 - (iii) there shall be no separate pass mark for Internal Assessment.

- (d) Re-Evaluation & Betterment Examination:
- (i) There shall be no provision for re-evaluation of answer scripts of end- semester examinations. However, a candidate may apply for re-scrutiny.
- (ii) A student shall be entitled to take the "betterment examinations" in any two theory courses of any of the six semesters after passing the Sixth Semester examination only once. In this case, the higher marks secured by the student shall be retained. The candidates shall have to apply for betterment examination within one year of passing the Sixth Semester examination.
- (iii) No betterment shall be allowed in the practical examinations.
- (e) A candidate who fails or does not appear in one or more courses of any end semester examinations up to Sixth Semester shall be provisionally promoted to the next higher semester with the failed course as carry over course(s). Such candidates will be eligible to appear in the carry over course in the next regular examinations of those courses.
- (f) If a candidate clears the sixth semester examination before clearing all the courses of the previous semesters, the result of the sixth semester examination of that candidate shall be withheld and his/ her results shall be announced only after he/ she clears the courses of the previous semesters.
 - A student must clear all his/ her Semester Examinations within Six (6) years from the dates of admission to the First Semester of any Programme irrespective of the number of examinations appeared by the student, viz. First and Second Semester Examinations shall have to be cleared in six consecutive chances, Third and Fourth Semester Examinations shall have to be cleared in five consecutive chances and Fifth and Sixth Semester Examinations in four consecutive chances. Under special circumstances, the candidates may avail the fourth chance in Fifth and Sixth Semester Examinations only. However, after the first chance of the Fifth and Sixth Semester Examinations, the candidate shall be considered as a non-regular candidate.

- (g) Since the Semester system involves continuous assessment there shall be no scope for a student to appear as a private candidate in any programme in this system.
- (h) A candidate shall be declared to have passed the Bachelors Degree in the concerned discipline provided he/she has passed all the Semesters and in all the Courses separately.

Grading System:

The following scale of grading system shall be applied to indicate the performances of students in Terms of letter grade and grade points as given below:

Exclusive Class Interval technique shall be followed in calculation of Grade Point.

- O The Letter grade 'B+' and above shall be considered as First Class and Letter grade 'B' shall be considered as Second Class.
- A student is considered to have completed a course successfully and earned the prescribed credits if he/she secures a letter grade other than 'F' (Failed) or 'Abs' (Absent/Incomplete).
- O If a candidate secures 'F' grade in a Course, he/she shall have to reappear in the Course in the next legitimate chance.
- O If a student secures 'F'grade in Project Work/ Dissertation/ assignment etc., he/she shall have to resubmit it after necessary revisions. The Result shall be declared with next regular batch.
- **O'Abs'** grade shall be awarded to a candidate if he/she has not fulfilled the following requirements:
 - i. If a candidate fails to appear in any Course(s) in an end semester examination.
 - ii. If a candidate fails to submit the project work/dissertation/assignment of an end semester examination.
 - ii. If a candidate is certified as not eligible to appear in any course(s) in and end semester examination by the Course Teacher(s) due to insufficient attendance in lectures, tutorials, practical or field works.
- O The candidates not appearing in a Semester Examination shall be considered as an 'Abs' candidate and that will be reflected in the Grade Sheet of the candidate. These candidates shall have to convert the 'Abs' grade by appearing in the next examination on the course concerned or by submitting project work/dissertation/assignment etc.

REGISTRATION:

- a) Candidates shall have to register themselves to Didrugarh University at the time of admission clearly mentioning their course/subject combinations.
- b) The college shall submit the detailed Registration List of the enrolled students to the University using the software provided by the University within one month from the date of admission or as prescribed in the University Academic Calendar.
- c) The Students registered by the University as per the information provided by the college shall be treated as final. Change of subject combination and switching from major programme to general programme and vise-versa shall be allowed in no circum stances.
- d)There shall be no provision for giving permission by the University for admission after submission of detailed Registration List of the enrolled students by the college concerned to the University.

GENERAL RULES FOR MAINTENANCE OF DISCIPLINE IN THE COLLEGE:

Students admitted to the college must abide by all rules and regulations of the college. Violation of the Rules and regulations, irregular attendance, misconduct and misbehavior, adopting unfair means at the examinations and the like will be treated as serious offences leading to suspension or even expulsion from the college. Ragging is strictly prohibited in the college campus. Organizations, societies etc. of the students of the college, will function only under the guidance of the college authority. Only the organizations/ societies recognized by the college authority will be permitted to use the facilities of the college premises. All the notices desired to be pasted or circulated within the college campus must be countersigned by the Principal.
