**ELECTION NOTICE**

The students of Lakhimpur Kendriya Mahavidyalaya are informed that the General Election of the Students' Union for the session 2019-2020 is scheduled to be held on **07<sup>th</sup> September,2019**. In this connection willing candidates are asked to collect the **NOMINATION PAPERS** for their Candidature in respective portfolio from the undersigned on payment of prescribed fee for contesting in the Election. The following Rules and Regulations shall have to maintain in the said election.

**RULES AND REGULATIONS:**

1. The date of Nomination Paper will be issued from **28.08.2019 at 12.00** noon to **31.08.2019 at 2.00 P.M** at the office of Election Officer, LKM.
2. The last date of the submission of Nomination Paper has been fixed on **31.08.2019** before **4.00 P.M.**
3. The fee of Nomination Paper is **Rs.500/-** (Rupees Five Hundred) only for each portfolio.
4. The Nomination Paper must be accompanied with the declaration form duly signed by the candidate.
5. The last date for withdrawal of the Nomination Paper is **02.09.2019** before **4.00P.M.**
6. The final list of the contesting candidates will be displayed on the Notice Board on **03.09.2019** before **4.00 P.M.**
7. The contested candidates will be allowed for canvassing from **03.09.2019 to 06.09.2019 up to 9.00A.M.** No canvassing /campaigning will be permitted beyond the prescribed schedule i.e **9.00 A.M on 06.09.2019.**
8. The date of election is **07.09.2019.**
9. The Polling time is from **9.00 A.M to 12.00 Noon on 07.09.2019** and the counting will be done from **1.30 P.M** on that day.
10. Stage campaigning will be held at **1.00 P.M on 04.09.2019** in the College.



### 11.PORTFOLIOS:

- i. **President** (Candidates belong to Degree 3rd Semester Class only eligible)
- ii. **Vice President** (Candidates belong to Degree 1st semester and 3rd Semester classes are eligible)
- iii. **General Secretary** (Candidates belong to Degree 1st semester and 3rd semester classes are eligible)
- iv. **Asst. General Secretary** (Candidates belong to H.S 1<sup>st</sup> Year, Degree 1st semester and 3rd semester classes are eligible)
- v. **Debating & Symposium Secretary** (Candidates belong to H.S 1st year, Degree 1st semester and 3rd semester classes are eligible)
- vi. **Magazine & Literary Secretary** (Candidates belong to H.S 1st year, Degree 1st semester and 3rd semester classes are eligible)
- vii. **Music & Cultural Secretary** (Candidates belong to H.S 1st year, Degree 1st semester and 3rd semester classes are eligible)
- viii. **Major Games Secretary** (Candidates belong to H.S 1st year, Degree 1st semester and 3rd semester classes are eligible)
- ix. **Minor Games Secretary** (Candidates belong to H.S 1st year, Degree 1st semester and 3rd semester classes are eligible)
- x. **Social Service Secretary** (Candidates belong to H.S 1st year, Degree 1st semester and 3rd semester classes are eligible)
- xi. **Boys' Common Room Secretary** (Candidates belong to H.S 1st year, Degree 1st semester and 3rd semester classes are eligible)
- xii. **Girls' Common Room Secretary** (Candidates belong to H.S 1st year, Degree 1st semester and 3rd semester classes are eligible)
- xiii. **One Class Representative from each classes to the Student Union.**

### Eligibility Criteria of the Candidate for Contesting in the Election.

1. The age of the contesting candidates must be in between **17 years to 22 years** as on **01.08.2019**.
2. Contesting candidates shall not be eligible if he/she is having **academic arrear** (subject back) in the year of contesting election.
3. The contesting candidates must be **REGULAR** students on the rolls of the institution. He/ She should be attended in his/her respective classes at minimum Percentage of attendance as prescribed by the University at least **75% Attendance**.(Certificate should be produced from the concerned department and be cleared all their dues or the college up to **May,2020**)
4. Contesting candidates must submit their **HSLC Admit card** (Xerox copy) along with Nomination Paper.
5. No election will be held for class Representative. The Election Officer will arrange to get the class representative selecting by each class **within one week** from the date of election.



**GENERAL RULES:**

1. A proposer or supporter will be allowed to propose or support **ONLY ONE** Candidate.
2. Proposer and Supporter must submit their up to date **COLLEGE DUES** clearance certificate issued from the office of the college.
3. Only those students wearing the College Uniform will be allowed to cast their votes by showing their **IDENTITY CARD/ADMISSION RECEIPT**.
4. One candidate will be allowed to contest against **ONE PORT FOLIO** only. In pursuant to directions of the Honorable **SUPREME COURT** in the matter to students' bodies/Union elections the Rules and Regulations shall have to maintain to the said elections by all concerned.
5. During the period of elections no person, who is not a student of the College, shall be permitted to take part in the election process in any capacity. Any person, candidate or member of the student organization violating this rule shall be subject to disciplinary proceedings, in addition to the candidature as the case may be being revoked.
6. **The candidate shall have one opportunity to contest for the post of office bearer, and two opportunities to contest for the post of an executive member.**
7. The candidate shall also not have a previous criminal record or convicted of any criminal offence.
8. The candidate shall indulge in, nor shall abet, any activity, which may aggravate existing differences or create mutual hatred or cause tension between different castes and communities, religious or linguistic, or between any group(s) of students.
9. No criticism can be made of other candidates.
10. No candidate shall be permitted to make use of **printed posters, printed pamphlets**, or any other printed material for the purpose of canvassing candidates may only utilize handmade posters.
11. No candidate shall be permitted to carry out processions, or public meetings, or in any way canvass or distribute propaganda outside the college campus.
12. Contesting candidates are not allowed to contest in election under the banner of political and Non political organization .If he/she found involve in this activities his/her candidature will be cancelled.
13. Regarding Election result if any complain /appeal arises, the concerned person will have to pay **Rs.300/- (Rupees Three Hundred)** only as a fee of complain/appeal





within the 3(Three) weeks from the time and date of the declaration of election result(excluding holidays)

14. The maximum permitted expenditure per candidate shall be **Rs.5000/(Five thousand )**only.

15. The candidate shall, within two weeks of the declaration of the result, submit complete and audited accounts to the College authority. The College shall publish such audited accounts, **within 2(Two)** days of the submission of such accounts, through a suitable medium so that any member of the student body may freely examine the same.

The students are hereby asked to go through the Rules and Regulations strictly, otherwise they will be in no way considered for contesting the election. **The decision of the Returning Officer will be final and binding in all cases.**
